SAFETY TIP

The Calgary Police Service is asking the public to ensure that their residences and garages are secured at all times. This includes during the night when occupants are sleeping. Police have encountered calls for service where offenders have entered into residences through screened windows and patio doors without disturbing the sleeping occupants. Please ensure all points of entry are secure.

Keeping Children Safe from Strangers

“Don’t talk to strangers.”

Reminding your children that they should never talk to strangers is very important – it helps you to protect them even when you’re not with them. Here are more tips that you can share with your children:

Remind children that a stranger is any person that they don’t know. Children should be taught to never accept gifts, food or toys from a stranger and never go anywhere with a stranger.

Let your children know that strangers might ask them to help find a lost animal or item. Children should be taught that this could be suspicious, and to trust their instincts; if the situation seems wrong, it probably is. They should know that they have the right to refuse to help a person they don’t know.

Remind your children to stay in open areas where they are visible to other people. If a stranger does try to grab them, they should kick and scream to get other people’s attention. When they are out of reach, they should run to the closest safe place. If a car follows them, they should turn and run in the opposite direction and go to a safe place for help. If possible they should try to remember what the driver and vehicle looked like, including the licence plate number.

Your child should know his or her full name, address and phone number including the area code. Older children should also learn their parents’ work, cell phone and pager numbers. Teach your child how to use a pay phone to make both local and long distance calls. You can also have your children carry cell phones that are pre-programmed with your phone numbers, but this shouldn’t replace memorizing those numbers. Your child should also know to dial 9-1-1 to contact police, fire and EMS in an emergency.

When kids go out, they should always use the buddy system and play with friends instead of playing alone. Set rules about where in the neighbourhood they are allowed to play. Children should never play in unsupervised areas such as vacant lots, empty buildings, construction sites, riverbeds and creeks, or in dark, wooded areas.

Show your child safe places in your neighbourhood where they can go for help. Find the location of Block Parent homes in your community: the Block Parent program (phone 269-6460 or visit www.calgaryblockparent.ca) offers a safe place for anyone in a dangerous or frightening situation. If your child is bullied, lost, hurt or frightened by a stranger, they can call on a Block Parent for assistance .
